The following information has been compiled by the Architectural Committee of the Spring Lake Property Association to clearly define the requirements to obtain a fence building permit. Most of the requirements are the same as set forth by the Highlands County Zoning Department.

DIFFERENT TYPES OF FENCE AND REQUIREMENTS

LANDSCAPE FENCE

There is no height restriction but must be trimmed and well maintained. It must be attached or adjacent to a building, patio, sidewalks, or flower garden.

PRIVACY FENCE

The maximum allowed height for a privacy fence is 6 feet. Slats are not considered privacy fencing for concealment if you can see through them.

CHAIN LINK FENCE

A chain link fence cannot exceed 6 feet in height, unless a particular covenant states 6 feet, and cannot go past the front corner of the house.

BOUNDARY FENCE

A boundary fence will be as described in the Highlands County Ordinance, fences, walls and hedges section. Boundary fence may be made of chain link, wood, vinyl, or hedge materials. Boundary fences cannot exceed 6 feet in height and cannot go past the front of the house.

DECORATIVE FENCE

Decorative fencing will be described in the Highlands County Ordinances, fences, walls and hedges section. Decorative fencing cannot exceed 4 feet in height and cannot exceed the front corner of the house and will not obstruct drivers at any street or intersection.

Ranch style and wire fence are not permitted.

INSPECTION PROCESS

After the homeowner returns the completed application two or more Architectural committee members will go to that property and visibly inspect the area of the property that is affected by the permit request. The area must be identified with markers.

The Committee members may consult with or advise the homeowner to assure the proper completion of the application.

After the installation of your fence, please notify the Property Owners Association at the office or by phone (863-655-2230) that the installation process is complete and has been inspected by Highlands County.

After completion of the fence, notify the Homeowners Association that the fence is ready for its final inspection.

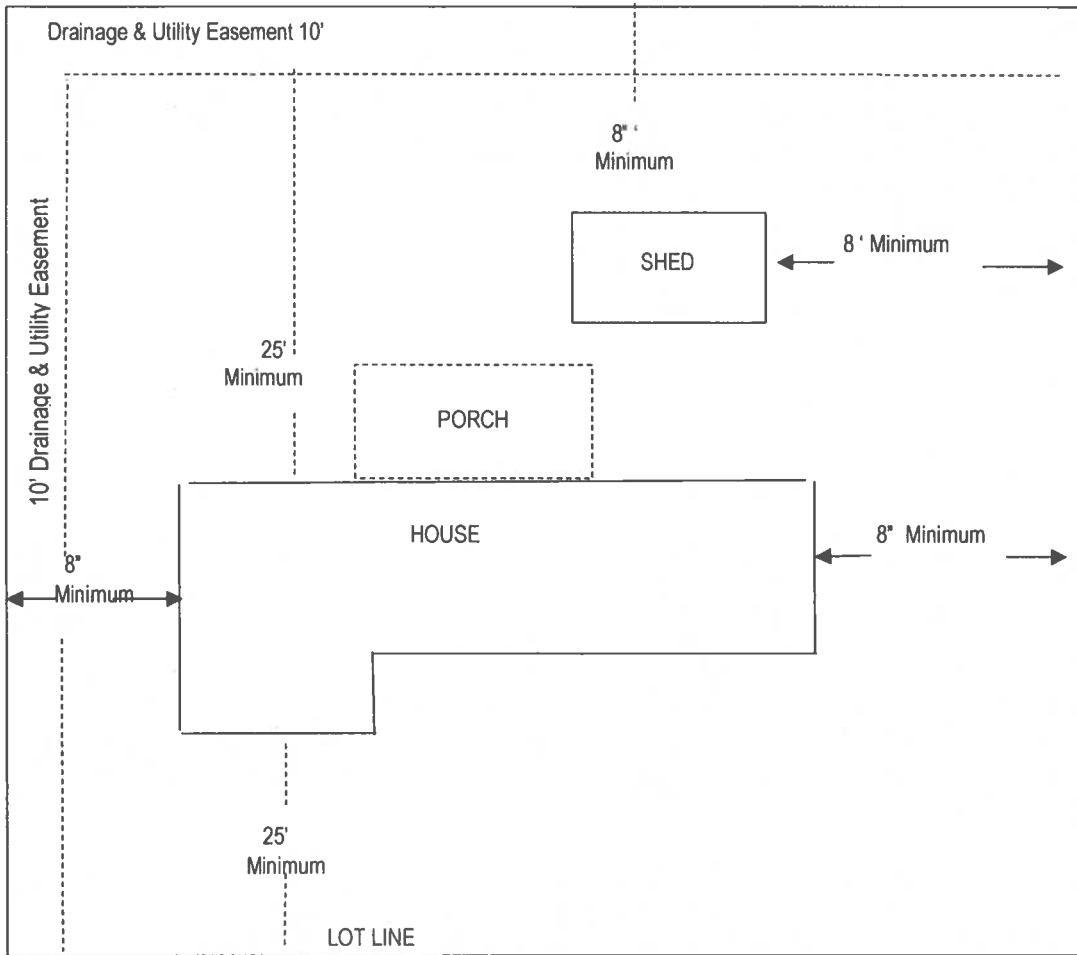


PLOT PLAN TO BE DRAWN BEFORE SECURANCE OF PERMITS

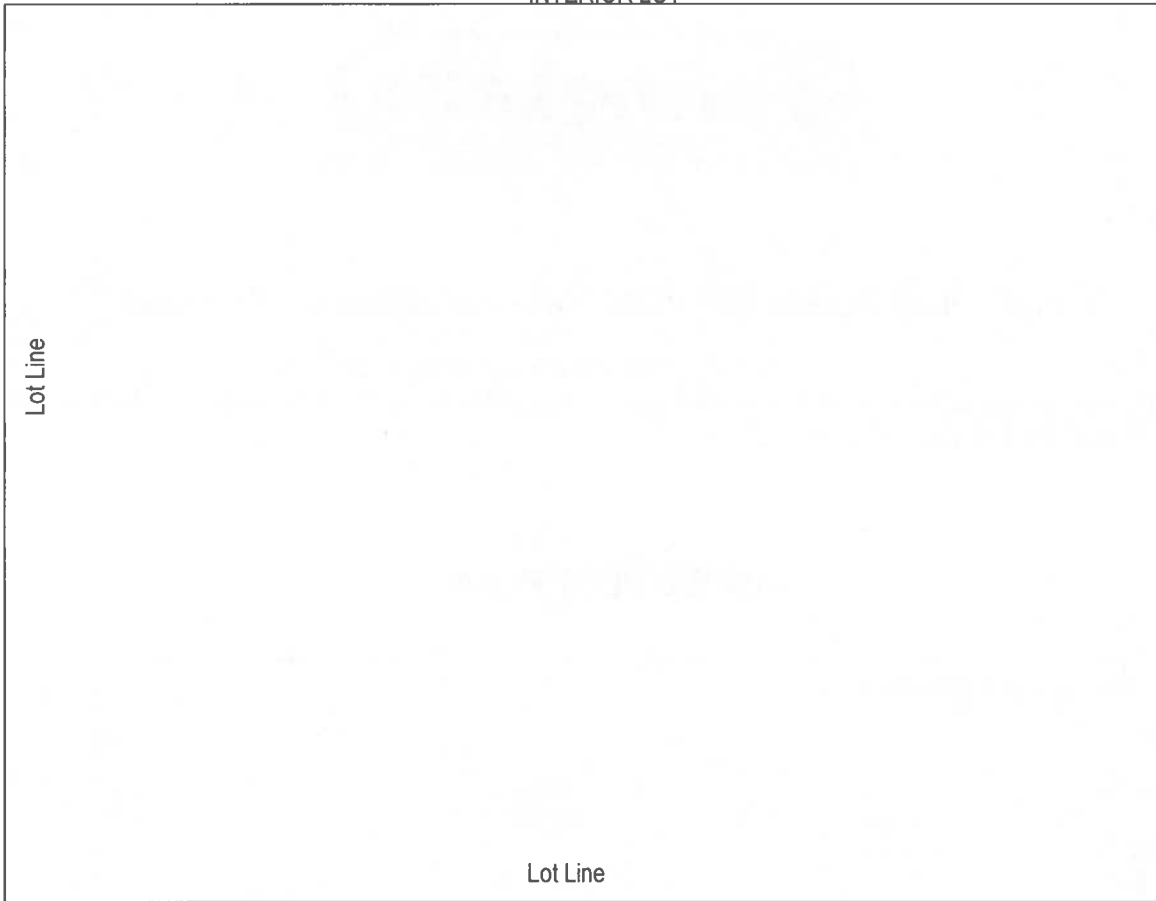
SAMPLE PLOT PLAN
